

Pacific STIHL SWEEPSTAKES
OFFICIAL RULES
NO PURCHASE NECESSARY

SPONSOR: Pacific STIHL, 30305 Bradham Drive, Visalia, California 93291

HOW TO ENTER: The sweepstakes takes place between February 15, 2008 and December 31, 2008. All entries must be submitted and received within these time periods.

ENTRY: You may enter by printing an official entry form posted online on participating Pacific STIHL dealers' Power Chord Web sites. Entry form must be completed and taken to the local STIHL Dealership to be valid. You must provide all information required on the entry form for your entry to be eligible. Incomplete entries will be disqualified. Only one entry per person per day is allowed. All entries submitted become the property of Sponsor and will not be returned.

ELIGIBILITY: The sweepstakes is open only to legal residents of Arizona, California, Hawaii or Nevada who are at least eighteen (18) years of age by January 1, 2008. Residents of other states, including Florida and New York, are not eligible to enter or win. Employees of Sponsor or its subsidiaries, affiliates, distributors, dealers, vendors, or advertising, marketing, public relations and promotional agencies are ineligible to enter to win.

PRIZES: One winner each will be selected in three (3) separate random drawings to be held in the second, third and fourth quarters of 2008 from all eligible entries received. The drawings will be conducted by an independent agency, under supervision of Sponsor on or about July 31, 2008, October 31 2008, and January 30, 2009. The odds of winning depend on the total number of eligible entries received. Entries not drawn in one drawing will continue to be eligible for later drawings. The winner of each drawing will receive a prize consisting of \$500.00 in STIHL products. The \$500.00 worth of STIHL equipment must be picked up from the winner's local STIHL dealer.

One grand prize winner will be drawn on or about January 30, 2009. The grand prize if the eligible winner is a resident of Arizona, California or Nevada consists of a trip to Waikiki, Hawaii; if the eligible winner is a resident of Hawaii the grand prize consists of a trip to Las Vegas; trip will include round trip coach air fare for the winner and one (1) guest from and to the major airport closest to the winner's home and hotel accommodations for six (6) days and five (5) nights to a hotel designated by the Sponsor (double-occupancy)(the "Grand Prize"). The odds of winning depend on the total number of eligible entries received. The approximate retail value of either trip is \$4,500.00, although the actual value of the trip may vary depending on travel arrangements.

All federal, state and local taxes associated with the prizes, as well as any other costs involved in claiming the prizes or any costs involved in participation in the trip that are not specifically included in the prize package, including but not limited to expenses such as meals, gratuities and telephone calls are the sole responsibility of the winner. Neither Sponsor nor any of its subsidiaries, affiliates, distributors, dealers or vendors has made or is responsible in any manner for any warranties, representation or guarantees, express or implied, in fact or law, relating to the prizes, including without limitation to fitness for a particular purpose of the prizes. The winner of the Grand Prize and his or her guest must have identical travel arrangements and must be able to travel on the dates designated by Sponsor. The winner of the Grand Prize and his or her guest are responsible for possessing all required travel documentation, including valid identification, and the guest must be at least eighteen years old. All transportation, accommodations and travel arrangements are subject to availability and will be made in the sole discretion of Sponsor. Sponsor is not responsible for flight changes or cancellations. The prizes are non-transferable, and no substitution or cash equivalency is permitted, except in the sole discretion of Sponsor or as provided in these rules. Sponsor reserves the right to substitute a prize of equal or greater value if the prize becomes unavailable for any reason.

WINNER NOTIFICATION: The winners will be notified that he or she has been selected as the winner by telephone, electronic mail or mail. If Sponsor is unable to contact a winner to notify the winner that he or she has been selected as winner, or if any notification is returned as undeliverable for any reason beyond Sponsor's control, the prize will be forfeited, and an alternate winner will be selected. In order to verify his or her eligibility, the winners will be required to present identification and to sign a Statement of Eligibility and Liability and Publicity Release before claiming the prize. If the winner does not fulfill their requirement, the prize will be forfeited and an alternate winner will be selected. If a person selected as the winner of the Grand Prize is unable to accept the trip included in the prize, then such person's claim to the prize will be forfeited and an alternate winner will be selected. Before a guest may accompany the winner on the trip included in the Grand Prize, such guest must also sign a Liability and Publicity Release.

By participating in the sweepstakes, each entrant offers permission to use his or her name, photograph, voice, biographical information, and likeness, in any and all media, for advertising and promotions purposes, without further compensation or notice, except as prohibited by law.
